CFT DIPLOMA REQUIREMENTS AND ELIGIBILITY

The following criteria must be met:

- ✓ All required courses must be completed with a passing grade “D” or better. (minimum 2.00 GPA)
- ✓ All courses must carry 3.00 credits unless otherwise noted.
- ✓ Up to 50% of the course credits needed for a specific Diploma may be transferred from a college or university, or by local credit review.
